This Schedule №1 is hereby incorporated into and made a part of the License Agreement, dated as of **29 APR 2009**, ("the Agreement") between **The Walt Disney Company Limited** ("Disney"), with its principal place of business at **3 Queen Caroline Street, Hammersmith, London, W6 9PE, England** and **Stadlbauer Marketing + Vertrieb GesmbH** ("Licensee"), with its principal place of business at **Magazinstrasse 4, A-5027 Salzburg, Austria**. The provisions of this Schedule shall be binding on Disney and Licensee upon full execution by both parties of the Agreement. The capitalized terms on this Schedule are defined in this Schedule and in the Agreement.

1. The **Term** of this Schedule begins on the **Effective Date** of 1st April 2009 and ends on the **End Date** of 31st December 2010.

Furthermore, the period from 1st April 2009 until 30th June 2009 shall be a period for Manufacturing and shipping only and there shall be no sale of Product on or before 30th June 2009.
